- **Bylaw Review** In an attempt to eliminate interpretation of our bylaws, the board has decided to refine some sections. This will hopefully leave less room for confusion.
  - Some of the changes include, but are not limited to, the playoff championship game will be determined by coin toss at the plate. Drop 3rd may be implemented for the season if 10U plays interleague. Chin straps will be continued to be required and better enforced. Bunting and slapping is only allowed during player pitch. The outfield is defined by the grass, and the infield is defined by the dirt. There will be no standings kept for 6U and 8U divisions. No new innings started after 120 minutes and drop dead at 140 minutes.
- NorCal/FAA Price increase is planned for next season and will be seen through registration fees. Scholarships are available. Rachel will help new VP set up fall ball questionnaires. Umpire fees and background fees are also increasing. Those that volunteered the fireworks booth will get a credit towards their registration. Community service day is in September and everything has been accepted. New shade at L3, mounds and bullpens. Jereme will come up with how much it will all cost. We may have to pay upfront and get reimbursed for some things.
- <u>Uniforms</u> The board is in discussion of some changes including moving the names below the jersey number and including the number on the front of the jersey. Discussion was made to have the team names reflect real D1 college teams and have the jersey colors reflect the team. We are understanding these changes will take more turnover time when ordering jerseys.
